Tips and Tricks for Writing an Eye-Catching Introduction

So, you need to write a paper and you are worried about how to get a start and write a catchy introduction to your paper. You are in luck today because you have landed just at the right place. An introduction to your essay is a very important aspect of your paper, assignment, essay, or any other form of write-up "reasonable prices". It tells your reader what to expect in the body paragraphs of your writing up and therefore a carefully crafted introduction will help you and your reader to connect all the relevant dots of the main arguments of your essay. So, without further ado, let's jump right in and explore some of the key components to writing an eye-catching introduction.



The introduction part of your write-up is naturally the first part that is read by the reader. So, if you think about it from the perspective of a reader then you will know what is expected from an introduction. Depending upon what kind of content you are writing, your introduction will vary accordingly. If you are writing an argumentative essay, and in case you don't know what that is so we are here to help you understand it. In an argumentative essay, you take a stance, make a claim and then defend it by citing evidence. You frame your essay around 4 to 5 main arguments and then each of your body paragraphs starts with a body paragraph. Then you have to also mention the opposing argument and then your counterargument to that in a different paragraph. Still, feeling confused? Well! hooking your reader into it. A hook can be a metaphor, a quote, a rhetorical proposition, or anything else that is catchy enough to engage your reader.

One another aspect of an eye-catchy introduction is to use strong diction choices. An essay is a serious piece of writing which requires a tone that is mature and sophisticated. However, there is a fine line between sophistication and wordiness which can ruin a write-up. The hook of your introduction should ideally consist of two to three lines maximum. Stretching it beyond that will not leave enough space for other parts of your introduction paragraph. Talking of paragraphs, the ideal length of a paragraph must be between 120 to 150 or a maximum of 180 words but this also depends upon the nature of your <u>professional writer</u>. For a normal-length paper, this would suffice. However, if you are writing a research paper then it will require a lengthier introduction which can go up to 300 words also depending upon the arguments that you have raised in your paper. In essence, the lengthier your paper, the similar the introduction. Now that we have deliberated upon the hook of your introduction and the length of the paragraph, we next move on to the main content of your introductory paragraph.

If you have done your research and now you are thinking that I have to write my essay then the introduction as evident from its name serves the purpose to introduce your topic to the reader. It should provide insights to your reader regarding what is coming up in the body paragraphs. However, an introduction does not include your main arguments in their entirety. That is to say that you have to give background knowledge or information of your content. It is not necessary to dwell completely on explaining each and every argument that is discussed in the body paragraph. That is because if you do so in the introduction paragraph then it will increase the length of your paragraph beyond reasonable length and also it will create redundancy in your arguments when you will explain them in detail in the body paragraphs. Regardless of this, an introduction introduces a topic generally to the reader from every aspect and its background. It is like a short summary of your entire essay in which you have to professional essay writer and concisely describe your main arguments. Talking of description, it depends on what kind of write-up it is but if is it is a research paper then in such context your introduction paragraph is generally more descriptive. Also, in a research paper, the hook of your introduction is not required. You have to basically only mention the main points of your paper because research is based on facts. There is little to no room for argumentation based on opinions in a research paper. Therefore, your factual arguments must be described in a manner that provides the background of your research.

The next and the most crucial part of an introductory paragraph is the thesis statement. An efficient <u>personal essay writer</u> will know that the thesis statement usually is present in the last one to two sentences of your introductory paragraph. A thesis statement is the culmination of your entire essay in one to two lines. A thesis statement of an argumentative essay usually includes one part of each topic sentence and establishes a claim based upon that. It is very important that the entire introduction paragraph is structured in a way that leads to the thesis statement naturally.

If a thesis statement is put out of place, then it will not form a logical sequence and it will ruin the entire structure of your essay. In other kinds of essays, where you are required to write an outline you can write your thesis statement before the outline as well but that entirely depends upon the requirements and the format of <u>WriteMyEssayFast</u>. Finally, if you are writing a research paper then the thesis statement of your paper will be different. Here your thesis statement will only describe what should be expected in the paper below and simply state that in one or two lines. That's about its folks, that is basically all the necessary information you need in order to get started with the introductory paragraph of your write-up.
